## The Board of Commissioners has adopted the following requirements and procedures, which apply to applicants for all Boards, Committees and Commissions (excluding the Senior Citizens Advisory Council):

- 1) All applicants, including applicants seeking reappointment, must contain the following required submissions:
  - a. The applicant's name, address, phone number and email address;
  - b. A cover letter or cover email listing each Board, Committee or Commission on which the applicant seeks an appointment or reappointment;
  - c. A concise statement (no more than one typed page) summarizing why the applicant seeks the appointment or reappointment; and,
  - d. A resume or other summary of the applicant's experience.
- 2) All applicants, including applicants seeking reappointment, must appear for a 15-minute interview, to be scheduled by the Board of Commissioner
- 3) Any applicant or incumbent who does not appear for an interview without good cause shall not be considered for appointment or reappointment.
